BROWARD COUNTY USBC BOWLING ASSOCIATION 'ADULT' HALL OF FAME CRITERIA

BOWLING ABILITY:

- Nominee shall be in good standing or had been in good standing with USBC
- Nominee considered on bowling accomplishments
- Must have been a Broward County resident and active in the Broward County area for a minimum of Ten (10) years
- Must have participated in five (5) Broward County USBC County tournaments
- Shall be of ethical character
- A Hall of Fame member may have his/her status revoked at anytime by the Broward County USBC Bowling Association Board for cause

MERITORIOUS SERVICE:

- Nominee shall be in good standing or had been in good standing with USBC
- Particular consideration shall be given to service rendered by reasons of pure devotion to the game. Working with the Junior program would be covered also.
- Must have been active in the Broward county (Broward Resident) area for a minimum of Ten (10) years
- Shall be of ethical character
- A Hall of Fame member may have his/her status revoked at anytime by the Broward County USBC Bowling Association Board for cause

NOMINATIONS:

Nominations will be accepted from anyone. If a category is not indicated on the application, the application will be returned.

ELECTION:

Applications will be voted on by the Broward County USBC board members at the October board meeting. 2/3 votes are required to be inducted into the Hall of Fame. Blank ballots will not be counted. Closed ballot voting will be used.

AWARDS

The inductees will be honored at the Broward County USBC Bowling Association County Tournament; if not applicable alternate arrangements will be arranged.

APPLICATION & RESUME:

Must be received on or before September 1 to be considered in the current year. **No applications will be held over, each year will require submission of your application and resume.**
