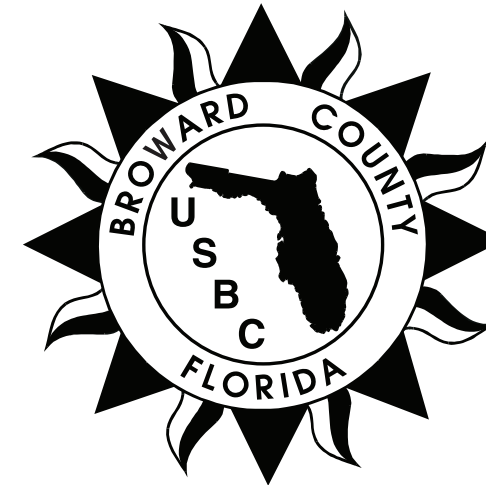

WOMEN'S COUNTY TOURNAMENT RULES 2009-2010**

This Tournament Will Be In Strict Accordance With The Rules Of The USBC, Inc.

- MEMBERS ARE REQUESTED TO WEAR SUITABLE ATTIRE WHEN PARTICIPATING IN THE COUNTY TOURNAMENT. **SKIRTS OR SLACKS ARE PREFERRED. NO SHORT SHORTS, NO TANK TOPS.**
- Bowlers with their **USBC Membership Cards** and **Local Membership Cards** must report to the check-in desk one hour before they are scheduled to bowl. Palm Beach and Miami/Dade WBA Bowlers Local Membership Fee is \$10.00. Local Membership fee must be paid with tournament application. Local Membership card will be mailed with confirmation letter.
- Entrants entering average will be the highest 2008-2009 Yearbook Average (Broward, West Palm Beach or Miami/ Dade) Only verifiable averages are accepted. Print out from bowl.com will be accepted. If an entrant does not have a 2008-2009 yearbook average and the bowler has a 2008-2009 verifiable summer **average, the highest** summer league average will be accepted for 21 games or more. If the bowler does not have either of these averages a verifiable January 1st highest average of 21 games or more will be used. All other will bowl scratch 200. The 10 Pin Rule of January 1st averages has been waived. If your entering tournament average is left handed you must bowl left handed. If it is right handed you must bowl right handed.
- Handicap will be figured at 100% of the difference between the individual average and 200.
- All participants of the tournament must be members of USBC.
- You may participate **TWO** times in TEAM events. Once with a different partner in Singles and Doubles Events. Teams may be organized from ALL LEAGUES IN WHICH WOMEN PARTICIPATE. The same 4 members may bowl only once as a Team. A change of 1 member must be made. You may cash twice in doubles and singles with a different partner.
- If you participate in more than one Team event or Doubles/Singles Event, the highest scores rolled in these Events will count for your ALL EVENTS.
- All Events will be Handicap. To be eligible for All Events an additional Three Dollars (\$3.00) per bowler must accompany the entry form. all Event prize fund will be returned 100%. First Place Winners of the Handicap Team/Singles events will receive an award.
- Bowlers entered in the DOUBLES event must also enter SINGLES Event. Bowlers entered in the SINGLES Event must also enter DOUBLES Event. DOUBLES WILL BE BOWLED PRIOR TO SINGLES.
- All three games in each event to be bowled on the pair of lanes assigned, unless an emergency arises.
- Tournament bowlers are permitted to leave the bowling circle or center to smoke during tournament play. If not present when name is highlighted a zero will be given for that frame.
- If possible, all substitutions should be made ONE HOUR before the scheduled time to bowl. Secretary will be permitted to put in a substitute where needed in case of emergency with the approval of the team captain. Substitute once started remains to complete event.
- No pacers will be allowed.
- Any bowler arriving after a scheduled shift has started will be permitted to bowl, unless a substitute has started. Her score to count beginning with the frame then being bowled. No score will be given for her frames missed.
- Tournament entrants must bowl in the order in which their names appear on the Tournament Entry Blank. In the case of substitution: the substitute must take the place of the absent member and RECEIVE the PRIZE MONEY for any event in which she bowls. Please check the line-up with the official score sheet.
- No Entry Fee will be refunded.**
- No change will be made in the scheduled time unless an emergency arises.
- Print-outs will be official.
- Any protest affecting eligibility or general playing rules must be confirmed in writing to the tournament director before the tournament prize payments are made. Errors in scoring must be reported to the tournament director within 24 hours.
- All games rolled with illegal bowling ball will be disqualified. Ball to be weighed in case of a protest. limit one ball per bowler on ball return.
- NO beverage, food, or unauthorized persons will be allowed in bowler's circle.
- If a team is scheduled alone on a pair of lanes, it is not necessary for the team's lead off to wait until the anchor has thrown her first ball before proceeding.
- In case of a tie for the team, singles, doubles or all events championship a roll off of one game will be held at a time and date set by the tournament director. If a tie still exists additional 10th frame will be rolled until the tie is broken.
- If duplication of personnel on teams tied for 1st, rule 326B applies.
- Rule 319D will not apply.
- Any questions not covered by the rules will be decided by the Broward County USBC Tournament Rules Committee as appointed by the Board.
